1). This registration is subject to the rule 3, 4 and 5 of Karnataka Private Education Societies (Division and Registration) Rules-1997

2). The Governing Council strictly follows the conditions as stated above.

3). It is subject to the condition to provide the facilities of School building, area, building, study, infrastructures and the financial facilities of the employees.

4). This Education Society cannot start further divisions without the prior permission of the Government.

5). The School shall be start in the place and medium permitted, there is no permission to change the place for any reason.

6). The School must be start by permitted Governing Council, in same place and in the same name.

7). This Education Society must follow all the orders and rules of Education Societies in force and changed for time to time and follow the laws and rules coming under The Karnataka Education Act-1983 (Karnataka Acts No: 1/95).

8). This Primary School permission is permanent un-aided as per the Government notification No: ED/175/PMC/95 dated: 7-9-98 and dated: 29-12-98. The Administrative Body Committee has to execute an agreement bond value of Rs: 20=00 declaring that they will not ask any aid from the Government, it is to be notarized by the notary.

9). It is also follow the rules as stated in Karnataka Private Education Societies(Private aided Primary and High School Education Societies Employees recruitment, Service terms and conditions) Rule-1999.

10). Only the Department and Government fixed Text books and Examination Method must be adopt without fail.

11). As per the government order No: ED 28 PGC 94 dated: 29-4-94 run the school up to 1 to 5th standard in Kannada Medium or in the medium of mother tongue of the student. The schools following the language rules are upgraded to 6th standard in English Medium and registered. In the schools registered under the language rules, if such schools are violate the language rules it is come to the knowledge of Government/Department/Kannada Development Authority. As per the rules such schools registration and permission are cancelled.

12). The schools which violate the language rules or with self interest getting the opportunity under the said project. Bound to the terms and conditions of the Court order and Government order if modified.

13). The Society must deposit the security amount in the joint name of Divisional Deputy Director and Administrative body.

14). In all permitted class the ratio of student and teacher is to be maintain according to the rules, in every class admission is 50 and presence is 40.

15). All the registered schools are coming under the purview recognition and provisional recognition according to sub-section-36-39 of article-8 of Karnataka Education Act.

16). Medical test of the student must be conduct every year as per rules.

17). Follow the working hours and days of the school according the rules.

18). Inform to this office about the opening of school and admission of the student within two months from the date of registration or from the starting of education year. If the school is not open and the conditions are not followed the registration itself cancelled.

19). The it is necessary to provide separate latrine and drinking water facility to boys and girls.

20). It is necessary to take all the precautionary action to protect the school building from fire, whirl wind, Electrical accident, etc., and all the precautionary measurements are taken according to the Building Code of India 2005.

21). Fix the fire extinguisher in the school and trained all the teachers and non-teaching stops to use of it.

22). To provide all the facilities to all the stops, as per the stop method teaching and non-teaching stops and according to the Karnataka Education Societies (un-aided Primary and High School and Pre-University Education societies Employees Service terms and conditions) rules-2005.

23). To give service securities, to maintain the service books and pay minimum salary of Rs: 6250=00/- through Bank. As per the Government order No: ED 104 SEP 2005 dated: 12-01-2006

24). The un-aided Education Societies posts also appoint the minimum qualified and trained teachers as appointed for the posts Government Education Societies As per the Government order No: ED 104 SEP 2005 dated: 12-01-2006 and as per the rules of the Department.

25). To start the school only when by appointing the teachers who studied in English Medium.

26). This school registration is for the 6th standard in English medium for the year 2012-13, the 7th standard will be run on the basis of natural development from the year 2013-14.

27). The sanction of Higher Primary English medium school will not effect in any way to the 1 to 7 Kannada medium standards.

28). As per the Education Act rules arrange all the necessaries like, infrastructures, study materials, Library books, play ground, school building etc., within one year from the opening of the school otherwise the registration will be cancelled.

29). If the school going to start is having a rental building, to take the declaration from the Block Education Officer in respect of the school building going to start the school and fundamental facilities are good and then start the school.

30). The Administrative Body has Rs: 5 lakhs fixed deposit or immovable property equal to that amount.

31). All Education Societies are having every year accounts certified by the Chartered accountant.

32). Strictly follow the rules regarding the admission of students and receiving fees from the student.

33). School, school premises the admission records of the students are kept open for all.

34). The school building is available for the examinations, Training, Census, etc., departmental activities.

35). To provide all the facilities as per the rules laid down in Karnataka Education societies (Division Control and Syllabus)Rules-1995.

37). This permission is provided subject to the terms and conditions to run the Kannada medium for 6th and 7th standard from the competent Authority.

38). If the documents annexed to with an application for registration are found for away from truth, under such circumstances the registration will be cancelled.

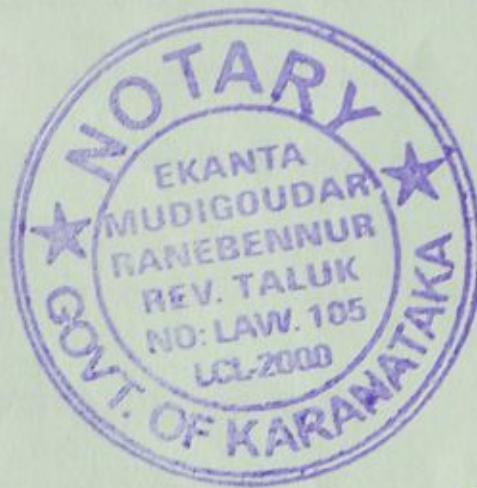
